Lakeside's 2020 Virtual Charge Conference.

In the **United Methodist Church**, the **charge conference** meets at least once a year and is responsible for recommending candidates for holy orders, establishing salaries for the pastor and staff, and evaluating the ministry of that parish **church**.

This year, all local church Fall Annual Charge/Church Conferences will be held virtually. Our church is scheduled for our virtual Charge Conference on Sunday, October 11, 2020 at 5:00 PM. Everyone in the church is invited to be a part of it. Those who are members will be able to vote on several of our yearly report documents in the Lakeside Church breakout session.

This year, there will be a two-step registration process for virtual charge conferences. All who will be attending must first register with the District. Here is the link to send out to your Leadership and congregation to register for your church. Individual registration is required by all who want to attend your Charge Conference by Sunday, October 4, 2020.

I have some great news to share with you. After much consternation and prayer, we have devised a plan to allow a small number of our folks to join us for worship on Saturdays at 10:00 a.m. when we do the recording of our Sunday worship service. This invitation will be by reservation only. We will allow 10 people with a reservation for that week to enter at 9:45 a.m. observing facial covering and sanitizing guidelines from the CDC and the UM Conference. We will be seating with social distancing in mind in designated seats that you will be escorted to by an usher. If you live in the same household with someone you will be able to be seated together, otherwise a minimum of 20 ft. distance will be maintained. An usher will be taking your temperature as you enter the sanctuary. These regulations may seem unreasonable to you but I am taking the utmost caution in protecting people that I love, and that's YOU! If for some reason we run into difficulty maintaining these protocols we will suspend the services until it is deemed safe to gather. You may make your reservation as early as today by contacting me by email or cell phone (561-389-6763) If we have more than 10, your name will be moved to the list for the following week. A first come first served timestamp of correspondence will be used to determine placement. If this works well we may be able to increase attendance in the near future. I am looking forward to seeing your smiling faces in worship even if it is behind a mask. I love you all and want us to be safe and together again in God's House.

If you do not respond, they will need to send a Census Bureau interviewer to your home to collect your answers in person. If you need help completing your 2020 Census questionnaire, please call toll-free 1-844-330-2020.

If someone visits your home this year to collect information for the 2020 Census, check to make sure they have a valid ID badge with their photograph, a U.S. Department of Commerce watermark, and an expiration date. Census workers may also carry Census Bureau bags and other equipment with the Census Bureau logo.
